#### Q8 Describe the projects/activity you plan to use this grant for.

The Shrewsbury Arts Trail, now in its fourth year, continually seeks to enhance and adapt to better serve the needs of the local community. We actively gather feedback from volunteers, visitors, and workshop participants annually. Based on this input, our objectives for 2025 are:

**Enhance Arts Opportunities for Children:** We aim to provide more high-quality arts activities for children in Shrewsbury. This includes collaborating with schools and community groups, with a specific focus on those schools that have had to reduce or cease their in-school art programmes. Local artists will lead sessions helping children to collaborate to create a huge community artwork.

**Promote Inclusion:** We strive to increase the participation of Shrewsbury children and young people with special educational needs and/or disabilities (SEND) in high quality arts activities.

Raise Environmental Awareness: Our goal is to foster greater environmental consciousness among visitors and participants during the Shrewsbury Arts Trail - facilitating discussions, encouraging sustainable choices and building community around this urgent issue.

**Need:** The need for the project has been identified through feedback gathered from volunteers (including venues who host Shrewsbury Arts Trail exhibitions and events), visitors to the Shrewsbury Arts Trail and participants in our workshops. We hear the considerable educational and wellbeing benefits that children experience from participating in high quality arts activities, the need for community building activity, the need for free and low cost activity for children during a cost-of-living crisis, the need for inclusive and accessible activities for children and young people with SEND and the increasing desire amongst Shrewsbury communities to see environmental responsibility front and centre in

#### **Benefits:**

• By fostering collaboration, shared experiences and a sense of belonging, the project will strengthen community bonds.

- Engaging local artists, community groups and schools in meaningful ways encourages a vibrant and supportive artistic community.
- By providing more high-quality arts activities, children in Shrewsbury will have greater exposure to creativity, self-expression and skill development.
- Collaborating with schools and community groups ensures accessibility and broad reach, benefiting a diverse range of children.
- Addressing schools that have reduced or ceased in-school art programmes helps fill the gap and enriches their educational experience.
- Increasing participation of children and young people with special educational needs and disabilities (SEND) ensures equal access to artistic experiences.
- Inclusion fosters a sense of belonging, boosts confidence and promotes understanding among all participants.
- By emphasising sustainable materials in community workshops, the project.
- Visitors and participants will gain awareness of environmental impact, leading to more conscious choices beyond the Arts Trail including responsible consumption and waste reduction.
- The project will build community around environmental responsibility, helping to foster connections and support those experiencing 'climate anxiety'.

**Timespan:** we are seeking funding to deliver activities during summer 2025 to co-include with the other sculpture trails, exhibitions and events delivered by Shrewsbury Arts Trail

150 children and young people, one local artist and many thousands of visitors who will get to view the finished artwork

The success of the project will be evaluated based on participant numbers and feedback from surveys. The entire Arts Trail attracts over 100,000 visitors and participants annually. Specifically for this project, we will deliver ten sessions with schools, early years providers and community groups, including SEND (Special Educational Needs and Disabilities) settings.

With an average of 15 participants per session (more for schools and fewer for early years settings), the project will engage approximately 150 children and young people who currently lack access to high-quality art activities. Participants will benefit from working with local artists, creating a large community artwork and having their work exhibited as part of the Shrewsbury Arts Trail 2025......

#### Q14 Sustainability

What plans do you have in place to ensure that your organisation becomes more sustainable and less reliant on grant funding, particularly from the Town Council?

We are working on a Fundraising Plan with tree key goals:

- Securing multi-year grants to increase the sustainability of Shrewsbury Arts Trail CIC and support multi-year programming;
- Diversify income streams to include sponsorship packages (launching 2024), donations campaign and earned income, and;

• Raise an additional £500/annum to add a young artists award to the programme and £5,000/annum to add an annual artists commission

To achieve this we are leveraging various sources and methods:

**Grant applications** – Identify and apply for relevant grants from arts council, trusts and foundations and charities that support arts/cultural engagement and rural/community development.

**Corporate Sponsorships** – Approach local and regional businesses to secure sponsorship for specific events, exhibitions or the overall programme.

Offer sponsorship packages with varying levels of benefits, such as logo placement, event recognition and exclusive experiences.

**Individual Donations** – Implement a donations campaign to encourage donations by visitors and participants that can afford without compromising Shrewsbury Arts Trail's commitment to removing financial barriers to participation.

Explore the possibility of establishing a reoccurring donor or membership model.

**Earned Income** – Explore opportunities for earned income streams such as merchandise and some ticketed events.

**One-Off Fundraising** – Explore options for fundraising events such as art auctions, galas or crowdfunding campaigns to raise awareness and attract donations.
