Invitation to tender for Quarry Main Gates, Removal of Gates, Assessment of Piers and Repairs to Piers,
Stripping, Repainting and Rehanging.

### **Background Information**

The Quarry Park is Shrewsbury's jewel in the crown, a 29-acre listed park. The beneficiary of a £1.5 million grant from the heritage lottery grant fund in 1998 seeing the works completed in 2005, attracting annually around 1.4 million visitors it is now one of the most visited and well used facilities in the town. The park hosts the Shrewsbury Flower Show and has a varied events programme throughout the year.

The gates in question are listed on Historicengland.org.uk, due to their grade II listing. The listing gives the following description:

Gates. Dated 1881. For Shrewsbury Horticultural Society. Cast and wrought iron. Central double gates and side gates between heavy piers with traceried panels Salop arms superimposed and crocked caps. Main gates cast and wrought iron with very ornate heavy panels incorporating roundels. Smaller outer gate to the left with barbed iron shafts and scrolled decoration. Cast at Coalbrookdale and dates with initials SHS.

#### **Required Works Brief**

Shrewsbury Town Council is seeking a contractor to investigate and carry out repair works to the main Quarry gates leading into the park. At least one of the main supporting piers is leaning with a suspected lean on another. It is envisaged that this tender will be required to be split into the following areas.

- (i) Removal of Gates from Piers to allow a thorough examination this is also to include the stripping, repainting and safe storage of gates until they can be rehung.
- (ii) Appraising required works on piers and ground stabilisation where required, all quotations are to include all ground works required and can include recommendations for future proofing the site. Consideration should also be given to installing drop bollard on the gate line to allow the gates to be opened at all times but keeping the site secure from unauthorised vehicles.
- (iii) Rehanging of gates following stabilisation works to pillars.

Whilst it is appreciated that a firm figure would be a struggle for the pillar works may not be available until further investigations are concluded, it is hoped that previous experience of contractors would lead to ballpark figures being available for the project.

All interested companies will be required to complete the Tenderer Questionnaire. Failure to complete all necessary paperwork will result in your tender being excluded from the process.

All companies are required to be member of either CHAS or Constructionline as well as being a member of Historic England recognised scheme. Companies without these memberships will be removed from the process.

A timescale for this project will be required to be agreed between Shrewsbury Town Council and the chosen contractor. The park is used for multiple events throughout the summer season and is the focal point for such civic events as the Remembrance Day Parade & Wreath Laying.

## The objectives of this project are as follows.

- (i) Straighten the Gate Piers
- (ii) Investigate and make good any ground movement.
- (iii) Strip, repaint and rehang the gates




