Greenfields Recreation Ground - Solar Lighting Requirement

Shrewsbury Town Council is currently sourcing a supplier to complete the following works at Greenfields Recreation Ground in Greenfields, Shrewsbury SY1 2QN nearest postcode.

What3Words location: adults.tins.human

There is an existing footpath on the site that runs adjacent to the allotments and connects the surrounding area to Greenfields Schools (west of the site) and Flaxmill Maltings (east of the site beyond the railway line). This area is a popular site for walking and exercising. Local residents would like to see lighting along the length of the path (approx. 8 columns). The path is approx. 205 Meters in length, please see mapping below.

Registering your interest

Please confirm your intention to submit a tender by emailing stuart.farmer@shrewsburytowncouncil.gov.uk ; this will allow you to be kept up to date with any further information connected to the project during the tendering process.

Basic specification for this project is as follows:-

- Supply and installation of solar lighting.
- A passive level of lighting to provide walker reassurance.
- Lighting to be directed to the footpath and be spaced at reasonable intervals to ensure adequate LUX levels.
- PIR sensors are expected to limit the ambient lighting when little or no foot traffic is using the area. As well as dusk to Dawn photocells should be incorporated.
- Timers are to be set at an agreed timescale to enable pedestrians to walk from one light source to the next without being in darkness.
- Low maintenance solutions with affordable replacement options for battery packs and heads
- Columns to have universal fittings to ensure future proofing.
- Ideally, the light specified in your quote should be able to be adjusted on site, after installation, if necessary, to determine appropriate LUX levels

Site Meetings can be arranged by contacting the named officer however, due the site being a public open space and open 24 hours contractors are welcome to conduct their own visits if preferred.
