Tenders are invited for the supply and installation of outdoor gym equipment at Greenfields Recreation Ground, Shrewsbury, this will be a new addition to the area to enhance the visitor attraction to the site. Please refer to the 'site information' section for site specifics.

All prices to be net, excluding VAT.

A map of the location is attached to this document with possible locations of the equipment however Shrewsbury Town Council are open to different locations if deemed necessary.

Any installation must comply with EN16630 – Permanently installed Outdoor Fitness Equipment Adults Taller than 1.4m.

Current API (Association of Play Industries) RPII (Register of Play Inspectors International) guidelines and methodology must be adhered to in respect of separation of dedicated play equipment.

A timescale for commencing this project will be agreed between Shrewsbury Town Council and the chosen contractor following the award of the contract. Ideally this install will not take place during school holidays unless this is agreed between the two parties. # **Equipment Layout**

It is expected that the equipment will be laid in a linear formation alongside the exiting pathway, it is expected that this layout will reduce the need for fencing and wet pour surfacing.

# Inclusive and accessible Equipment

It is vital that there is inclusive and accessible equipment installed, this can be achieved by either the equipment being able to be used from a wheelchair or an easy transition from the wheelchair,

Residents have compiled a basic wish list of equipment for the site, this includes the following

- Arm & Pedal Bicycles
- Multigym units
- Squat equipment
- Steppers
- Rower


