This will be a proactive document to be used alongside existing policies and cannot be used retrospectively. The British Transport Police and Street Pastors will also be involved.

Sheffield has created a similar document which the Town Clerk will circulate. The document will give guidance on managing the dispersement of crowds from events in the town centre and also the Quarry.

A draft guidance document will be available in September/October 2016 when further public consultation will be conducted. It is intended to be adopted in Spring 2017.

Members were concerned that by involving so many departments for what they regard as a planning issue will over-complicate the process but are open minded and look forward to seeing how this progresses.
