67/16 MINUTES OF THE LAST MEETING

68/16 MATTERS ARISING

There were no matters arising.

69/16 PRESENTATION ON MEOLE BRACE ROUNDABOUT INTEGRATED TRANSPORT WORKS

The meeting was joined by Matt Johnson, Strategic Transport and Contracts Manager for Shropshire Council and Gary Dymond from Mouchel.

69.1 North West Relief Road

Mr Johnson announced that in the Autumn Statement nearly £1 million Department for Transport funding has been allocated to the North West Relief Road project. This will be used to fund the creation of a business case and revisit evidence gathered at previous consultations. The project will also receive £50k revenue support funding which has to be spent within 12 months from 2017. Shropshire Council will be contributing match funding of £50k local revenue funding.

Mr Johnson stated that this Local Majors Funding does not guarantee the project will come to fruition but it is a positive step forward. Shropshire Council was one of just six applicants who were awarded funding out of the 60 that applied.

Consultations with all stakeholders will be conducted alongside the creation of the business case.

The new road that will run from Battlefield to the Welshpool Roundabout near the watertower, has support from the MP Daniel Kawcynski and Councillor Price expressed his delight at the news. Residents and businesses in the Battlefield Ward have also welcomed the announcement.

Councillor Nutting asked what else could be considered whilst these plans are being drawn up such as scope for flood retention at Oxen, improved links to the town centre etc. Mr Johnson confirmed that these additional factors add both value and costs to the project. Some ideas will be revisited, others have already been dismissed but the final relief road design will be future proof and cost cutting options considered. The Oxen Link Road and ongoing Integrated Transport projects have been designed to work with the North West Relief Road.

69.2 Integrated Transport Works

Works to the Meole roundabout started 5 weeks ago and the focus so far has been to redivert the services. This will be completed by Friday 02 December. The main works have gone out to tendor and the work will commence in February 2017.

The new scheme is designed to accommodate additional traffic arriving from Oteley Road when the new housing developments are completed over the next 5 years. Meole Roundabout's current infrastructure would be unable to cope with this additional traffic hence future proofing the junctions.

An additional lane will be created through the middle of Meole Roundabout, enabling motorists to travel North to South without going through 3 sets of traffic lights as currently. It will also relieve the traffic flow from Oteley Road. The centre of the roundabout will become accessible to pedestrians and cyclists and will be landscaped, some existing trees retained and a water detention basin will become a feature. Digital signage which can be updated with messages live, will become permanent on the roundabout and will encourage motorists to use Hazeldine Way as a main route to the town centre.

The existing signage which gave motorists advance notice of the works triggered an online petition of 3500 people objecting to the plans. Mr Johnson confirmed that extensive consultation work was carried out prior to the plans being drawn up, all feedback received was considered by the forum and the consultation process will not be reopened. There is now a committement to proceed and deliver the project in it's entirety.

No works will be carried out over the festive period and measures are being put into place to minimise disruption to motorists.

Councillor Baker explained that the objections are mainly that these works will not ease the problems associated with getting onto Meole Retail park. Mr Johnson reiterated that these works are future proofing for increasing traffic flows following substantial developments off Oteley Road, not solving current issues. Mr Johnson sympathised with the Councillors concerns about the traffic flow problems on the retail park but as this is private property, it is out of Shropshire Council's jurisdiction.

Councillor Roberts argued that a slip road from the highway could be added to help the situation.

Many members of the public were concerned about the loss of trees, ecology and habitat, disruption and value for money. Mr Johnson confirmed that all reinstatement works will be paid for and carried out by Shropshire Council but Shrewsbury Town Council's input would be valued. Most of the stone features will be avoided by the new works but otherwise they are lifted, saved and reinstated. Two thirds of the trees will be retained but for every tree lost, two additional trees will be planted somewhere in the town.

The future maintenance of the island will be discussed further by the R&L committee.

Mr Johnson was confident that this scheme will be a success as it is a tried and tested solution. He accepted that the bridge built in 1937 cannot be widened and is not fit for modern purposes but this scheme is not making that aspect any worse. The traffic lights by the garage will be upgraded so they are synchronised with the signals on Meole Roundabout and the crossing points will be triggered upon demand only.
