10/18 MATTERS ARISING

10.1 Reconsultation on Application 18/01727/FUL – 3 Coton Hill

The committee were asked to reconsider the above application due to amended plans received. Members noted the amendments and raised no concerns.

RESOLVED:

That Shrewsbury Town Council raised no objections to the latest amendment to this application.

10.2 Ref Min 7.1 Trees

Since the last meeting, Members' concerns about the increasing number of applications to fell and prune trees in the Kingsland area have been raised with Mr Shields, Shropshire Council's Tree Officer.

Mr Shields was not concerned about the number of mature trees being lost in this, and neigbouring residential areas. However, he was more concerned that the whole tree stock, which is around 100 years old, will reach maturity at the same time. The tree stock requires managing, which will require felling healthy trees, and replenishing to ensure a continued supply of trees for future generations and Mr Shields has spoken to all applicants about this matter. This also applies to other mature tree stocks in Shrewsbury including in the Quarry.

Members would welcome the opportunity for Mr Shields to attend a Planning Committee meeting to discuss these issues and explain Shrewsbury's tree management programme.

RESOLVED:

That Shropshire Council's Tree Officer, Stephen Shields, be invited to a Planning Committee Meeting to talk about managing tree stocks in Shrewsbury.

10.3 Ref Min 3.2 Red Barn Public House and Car Park – Asset of Community Value Councillor Dean reported on the recent listing of the Red Barn Public House as an Asset of Community Value. This listing had been requested by CAMRA. Subsequent to the original listing representations had been made to Shropshire Council to warrant a part of the area to be de-listed. Councillor Dean was concerned that when CAMRA had questioned the de-listing, Shropshire Council had not provided any rationale for de-listing. He would raise this with relevant officers at Shropshire Council.

11/18 HIGHWAY ORDERS

11.1 Street Naming Proposals for the Residential Development on Radbrook Road Members were asked to consider several proposed street names for the development off Radbrook Road which reflected the history of the site when it housed Radbrook College. Whilst acknowledging the connections to the past members questioned whether 'Cookery Place' was an appropriate street name and suggested 'Cook's Place'.

RESOLVED:

That the Town Council is generally supportive of the streetnames as suggested for the Radbrook College Development Site. Members did however suggest changing 'Cookery Place' to 'Cook's Place'.

11.2 Stopping Up Order on unnamed road near the Flaxmill

Members noted the stopping up order on the unnamed road near the Flaxmill which the Council had previously raised no objection to.
