24/18 MATTERS ARISING

24.1 Reconsultation on Application 18/02331/FUL - 8 South Hermitage

The committee were asked to reconsider the above application due to amended plans received. The Town Clerk shared comments received from the resident of number 10 South Hermitage. After considering all the new information, Members agreed that the amendments were not significant enough for them to change their objection and that their comments remain. If the Planners were mindful to approve this application, the Town Council requests that the application be considered by the Central Planning Committee.

24.2 Reconsultation on Application 17/05538/FUL - The Stew

The committee were asked to reconsider the above application due to amended plans received. Members recalled that they were generally supportive of the previous design, but had concerns about the treatment of the top floor and the contemporary nature of the roof treatment; they wished to see more of a traditional pitch. Members were unanimously in agreement that these changes did not address any of the Town Council's concerns about the contemporary design of the additional floor and if anything it was a less sympathetic design than the previous iteration. Members remained of the view that a more traditional pitched style would be more appropriate.

That the Town Council objects to the latest version of this application and their original comments remain relevant.

24.3 Reconsultation on Applications 18/02433/LBC and 18/02424/ADV - The Wheatsheaf

The committee were asked to reconsider the above applications due to amended plans received. Members considered that the changes went some way to addressing their concerns and therefore supported the application as per the latest amendment.
