31/18 MATTERS ARISING

31.1 Reconsultation on Application 18/01379/FUL – 283 Monkmoor Road

The committee were asked to reconsider the above application due to amended plans received which showed a reduced extension compared to the original plans. Members raised no concerns to these amended plans.

RESOLVED:

That the Town Council raises no objections to the amended plans.

31.2 Reconsultation on Application 18/02421/FUL – 101 Oakfield Road

The committee were asked to reconsider the above application due to amended plans received. The committee recalled that they objected to the original application on the grounds that the proposed extension was disproportionately large compared to the existing size of the property. As the amended plans showed a reduced extension, members were happy to withdraw their objection.

RESOLVED:

That the Town Council withdraws its original objections to application 18/02421/FUL and raises no concerns to the amended plans.

31.3 Ref Min 24.1 Reconsultation on Application 18/02331/FUL – 8 South Hermitage

The Town Council reconsidered this application at the last meeting and remained against the proposals. Since this meeting, the Chairman of the Committee had been approached by the applicant wanting to discuss the application. The Chairman had advised because of his role both on this Committee and the Central Planning Committee it was inappropriate for him to meet the applicant but suggested that the applicant would be best addressing the full Planning Committee. A response had not yet been received.

31.4 Application 18/03166/EIA – Oxon Link Road

The Town Clerk has been approached by Mr Goddard, Managing Director of Oxon Touring and Holiday Home Park who has concerns for the future of the caravan park should the Oxon Link Road be constructed as per the latest plans.

The company want to support the Link Road proposals as they are not against the principle of this, or the North West Relief Road, being constructed but their concerns have been raised and ignored by Shropshire Council's Highway department leaving them only the option of objecting to the plans. Mr Goddard was seeking the support of the Town Council in helping to open up discussions.

The caravan park currently plays a big role in supporting tourism in Shrewsbury and provides customers to the Park and Ride service and also the local shopping centre. The caravan park had requested what they felt were reasonable mitigating measures including:

- A safe crossing or footbridge to be provided to ensure a safe access to the Oxon Park and Ride, local shops, take-away, pub etc. The current plans put pedestrians at risk and 400 people cross here daily.
- There is no sound bunding or fencing included in the plans to protect the caravan park despite numerous requests.
- During the stages of constructing the road, there is no promise of unhindered access to the park and services at all times and the impact of noise, dust etc during this time on the caravan park is unclear.

Members were sympathetic to Mr Goddard's concerns and supported the motion for the Town Clerk to raise these concerns with Shropshire Council's Head of Economic Growth and request Shropshire Highways Department to review the scheme.

RESOLVED:

That the Town Clerk writes to the Head of Economic Growth and Shropshire Highways to raise awareness of Mr Goddard's concerns.

31.5 Ref Min 28.1 Application 45 (18/03005/FUL) - 54 Monkmoor Road

The committee were asked to review their objection to the above application since it has been amended to exclude the detached garden building. As the amended plans were unavailable on ePortal, Members agreed to review this application at the next Planning Committee meeting.

RESOLVED:

That application 18/03005/FUL be reconsulted on at the next Planning Committee meeting.

32/18 PRESENTATION FROM ALDI

The meeting was joined by George Brown, Sarah Rhodes and Joanna Gabrilatzou who made a presentation on plans for a new Aldi store off Oteley Road. At the end of July they secured the 6-acre site in front of Percy Throwers Garden Centre; this site previously received planning permission for a larger Waitrose store. The site will be mixed use to include the Aldi supermarket and the other half will be for care and extra care facilities. A restrictive covenant on the site prevented other kind of facilities such as restaurants, cafes etc. Mr Brown explained how Aldi had explored alternative sites for their store including near to Dobbies, in place of Toys 'R Us on the Meole Brace retail park and the Pitch and Putt site. The operator of the care facilities is to be confirmed within the next few weeks.

The plans show a 1,350sq metre store with 161 parking spaces and will create over 40 jobs, the care homes hope to create around 100 jobs. Aldi hope to recruit local people who can preferably walk to the store and the recruitment process will proceed in the next few weeks. For comparison, the store at Battlefield is 1,080sq metres and has around 110 parking spaces. The plans also include retaining a green periphery of the site and a dock in the back of the building where delivery vehicles can go inside. The building will be made

from local brick, timber and cladding panels colour anthracite grey. The inside will have a spacious feel and the signage details are to be confirmed.

Shropshire Council's masterplan show this site as a local centre so Aldi hopes to provide a balance of providing for the local community without taking away trade from existing local businesses. The highways aspect of the application have been agreed in principle and with the Battlefield store over trading there is a clear demand for a store at this location. Mr Brown expects the two stores to settle to a similar level of sales once established.

Aldi will submit a hybrid application in early September 2018 for a mixed-use site to include a full application for the supermarket and outline for a care home with the Care home operator(s) submitting a reserved matters application in the New Year. Aldi hope consent will be granted around the end of the year so they can be trading within 12 months from now

Mrs Gabrilatzou assured Members that 161 parking spaces would be sufficient for the predicted trade and as the average shopper is in the store for 25 minutes, there is a quick turnover of parked cars. This also helps the traffic flow.

Members supported the application and would await the formal application in due course. They thanked the team for attending the meeting.

George Brown, Sarah Rhodes, Joanna Gabrilatzou, Councillor Mrs J Mackenzie and one member of the public left the meeting.
