57/18 MATTERS ARISING

57.1 Reconsultation on Application 17/06157/FUL - Proposed Commercial Development Land To The South Of Thieves Lane

After reconsidering the latest developments on the above application, members were supportive of the principle of the scheme but had discussions over boundary treatments, storm filtration tanks, noise mitigation from the A5 and associated landscaping.

RESOLVED:

That the Town Council raises no objections to this application but makes the following comments:

- That assurance is given that any noise mitigation measures from the A5 are done so sensitively and that appropriate soft landscaping is incorporated;
- That all storm tanks are built to accommodate a 1:100 year flood episode;
- That any boundary treatments are reflective of the site's visual prominence off the A5.

57.2 Update regarding Application 18/03378/FUL - 11 Longden Road

The Ward Member, Councillor Taylor provided the committee with the latest developments on the above application. Previously the Town Council had objected to the installation of a roof terrace over the whole of the roof. It was reported that part of the roof has an existing permission for a roof terrace. Therefore the applicant has withdrawn proposals for a roof terrace across the whole roof, but still wishes to retain the glass and steel balustrading around the perimeter of the whole roof for safety reasons during any maintenance. Members felt this was neither necessary nor appropriate and wished to see the balustrade restricted to the roof terrace area only.

RESOLVED:

That further to recent objections to this application, the Town Council notes that the proposed roof terrace has been reduced to the extent of an existing permission. Any balustrading should be limited solely to this area and not the whole of the roof surfacing.
