56/24 PROPOSED DIVERSION OF PUBLIC RIGHT OF WAY FOOTPATH - Oak Farm, Mytton Oak Road

The Office Manager informed Committee that Shropshire Homes Ltd were looking to develop the site off Mytton Oak Road, Shrewsbury, adjacent to the A5, which was in the process of obtaining planning permission for up to 400 dwellings and a care home. They had contacted Shrewsbury Town Council as part of the proposals, the route of public right of way FP 47Y would need to be diverted and they had

provided the PROW Diversion Plan, which identified the existing and proposed footpath routes. To formalise the diverted route, Shropshire Homes Ltd had made an application to Shropshire Council under section 257 of the Town and Country Planning Act 1990 for a footpath diversion order and in order to progress this Shropshire Council had requested that they consulted with the Town Council and sought their views on the proposed diversion. They requested comments by 15th October 2024.

Councillor Wagner commented that as the development was ongoing at this location this was unavoidable. He had spoken to local residents and although it was unfortunate they didn't have any objections and it appeared to have been organised properly.
